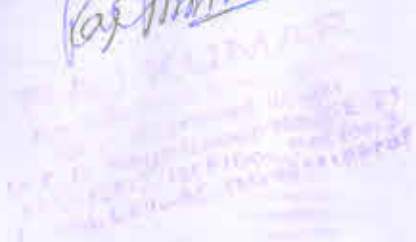

2. In case of structural failure, the sole responsibility lies on the part of Structural Engineer and action can be initiated as per Law.

**Penal Action :**

1. Penal action against defaulting Structural Engineer can be taken as per the provision of Unified Building Bye Laws of Union Territory of Delhi-2016.
2. The above Professional shall ensure compliance of relevant provisions of Building Bye Laws to be read with relevant **Regulations** applicable for the Licensing of Structural Engineer framed by three Municipal Corporations from time to time as well as Undertaking submitted by him at the time of registration / renewal.
3. The license is valid only for the purpose of building permits & supervision of construction, regularization cases and completion certificate cases only under the jurisdiction of South Delhi Municipal Corporation, North Delhi Municipal Corporation and East Delhi Municipal Corporation.
